### **What investment services and advice can you provide me?**

We offer variable life insurance products to retail investors. There may be a minimum investment for these offerings. Please refer to the prospectus for important information about the investment options, death benefits and other features. We provide recommendations on the initial separate account allocations. We do not monitor your investments.

***Key Questions to Ask Your Financial Professional***

- ✓ **Given my financial situation, should I choose a brokerage service? Why or Why Not?**
- ✓ **How will you choose investments to recommend to me?**
- ✓ **What is your relevant experience, including your licenses, education and other qualifications? What do these qualifications mean?**

### **What fees will I pay?**

The principal fees and costs associated with engaging our firm for brokerage services are commissions. Commissions are paid when investors remit initial and ongoing premiums to the carrier. These fees are outlined in the prospectus.

***You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.***

***Key Questions to Ask Your Financial Professional***

- ✓ **Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?**

### **What are your legal obligations to me when providing recommendations? How else does your firm make money and what conflicts of interest do you have?**

***When we provide you with a recommendation, we have to act in your best interest and not put our interest ahead of yours.*** At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the recommendations we provide you. Here is an example to help you understand what this means.

- Different carriers have different commission schedules. Therefore, commissions on similar products may be higher at one carrier than others. The variance in commission levels paid on similar products may give rise to a possible conflict of interest.
- Registered representatives providing securities recommendations may also be licensed as an independent insurance agent.

- ✓ **How might your conflicts of interest affect me, and how will you address them?**
